Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and with reference to our earlier announcement dated 10th March, 2021 intimating major fire break out and disruption of operations at Sanaswadi plant, Pune, Maharashtra of Sintex-BAPL Limited, the Wholly Owned Material Subsidiary of the Company, we hereby intimate further updates as below:

Sr. No.	Particulars	Disclosure
1.	Expected quantum of loss/damage caused	Loss/damage to the tune of INR 52.19 Crores is expected due to fire at the Sanaswadi plant
2.	Insurance amount claimed and realized for the loss/damage	Insurance claim proceedings for provisional loss amount has been initiated and it is expected that insurance claim will be settled and amount will be realized within next 4 to 6 months time period
3.	The actual amount of damage caused due to fire	Insurance claim has been initiated based on provisional loss amount and ascertainment of final loss amount is in progress
4.	Details of steps taken to restore normalcy and the impact of the fire on production or service, financials of the Company	Due to several measures have been taken to restore normalcy and resumption of operations at various affected divisions of the plant, all divisions except injection moulding division have resumed operations. Resumption of Injection Moulding division is dependent upon availability of funds upon settlement of claim with insurance company
